

Northern Kentucky Nursing Facility Checklist

The data collected on the following list of Nursing Homes was obtained from the facilities and through Medicare. (www.medicare.gov) Visit several Nursing Facilities (Homes) before you make a decision. When you visit, you should request to see the latest **“Office of Inspector General Survey Report.”** If there are any deficiencies, ask when/if these were corrected.

As a resident, or a perspective resident of a Nursing Home, you have certain rights.

1. You must be informed in writing about the services and fees before you enter the home.
2. You have the right to be treated with dignity and respect.
3. You have the right to manage your own money or to choose someone else you trust to do this for you.
4. You have the right to privacy and to keep and use your personal belongings and property as long as they don't interfere with the rights, health or safety of others.
5. You have the right to be informed about your medical condition, your medications, and to see your own doctor. You also have the right to refuse medications and treatment (but this could be harmful to your health.)
6. You have the right to spend day-to-day time in a way that means something to you.
